INVITATION NOTICE FOR SUBMISSION OF OFFERS FOR PURCHASE OF MATERIAL AND CONSUMABLES FOR THE HOSPITAL IN BETHLEHEM - HARMALAH

5. Eligibility and rules of origin

Participation is open on equal terms for private business entities (companies).

Tenderer shall not be considered eligible if:

1. Tenderer is bankrupt, are having their affairs administered by the courts, have entered into an arrangement with creditors, have suspended business activities or are in any analogous situation arising from a similar procedure provided for in national legislation or regulations;
2. They are the subject of proceedings for a declaration of bankruptcy, for administration by the courts, for an arrangement with creditors or for any similar procedure provided for in national legislation or regulations;
3. They have been convicted of an offence concerning professional conduct by a judgment, which has the force of res judicata;
4. They have been convicted by final judgment of participating in a criminal organization, corruption, fraud or money laundering;
5. They are guilty of professional misconduct proven by any means, which the Contracting Authority can justify;
6. They have not fulfilled obligations relating to the payment of social security contributions in accordance with the legal provisions of the country where they are established; or have not fulfilled obligations relating to the payment of taxes in accordance with the legal provisions of the country where they are established;
7. They are guilty of serious misrepresentation in the supplying of the information required by the Contracting Authority as a condition of participation in the Invitation notice for submission of offers procedure.
8. They have been declared to be in serious breach of Contract for failure to comply with obligations in connection with another Contract with the same Contracting Authority or another Contract financed by community funds.

Tenderers shall certify by an affidavit statement (Form of Affidavit Statement – Annex II) signed by their representative to the Contracting Authority that none of the situations detailed in Sub-Clauses 1 to 8 inclusive above applies to them.

If it is determined that the above statements are not accurate the Tenderer agrees that the offer will be declared inadmissible by Contracting Authority, and as such rejected as administratively non-compliant. Such rejection applies to and can occur at any stage of the tender selection process, contract signing and/or during implementation of the project works.

6. General terms

- The currency of donation is the United States Dollars (USD), therefore prices of the offer should be expressed in USD and should include VAT. The equipment must be delivered to the Palestine Hospital, Bethlehem (Harmalah) and the transportation costs must be included in the final price presented in the offer. The Contracting Authority (ITF) reserves the right to select the best Tenderer for each/separate type of material and consumables and final selection will be made based on the funds available for the project.
- The warranty period for all items should be at least one year. Samples of certain items might be requested.
- The Tender and all correspondence and documents related to the Tender exchanged by the Tenderer and the Contracting Authority (ITF) shall be written in English, which is the language of procedure for this tender. Also, all correspondence for payments including pro-forma invoice invoices, and final payment certificates shall be sent to the Contracting Authority (ITF) in English or local language with English translation.
- This Invitation notice for submission of offers is governed by the laws of the Republic of Slovenia.
- Tenderer shall bear all costs associated with the preparation and submission of his Offer. In no case the Contracting Authority (ITF) will be responsible or liable for such costs, regardless of the process or results of the Invitation notice for submission of offers procedure.
- In case the Tenderer acts as a party in a joint venture or a consortium of tenderers, the contract shall be enclosed (i.e. a Partnership Agreement) stipulating how the public contract awarded within this procurement procedure will be executed, specifying, in particular, the leading partner authorized to assume from the Contracting Authority (ITF) obligations, instructions, and possibly payments on behalf of and for the account of all the partners, and the share and type of services to be performed by each individual partner. The Agreement shall clearly stipulate that in relation to the Contracting Authority (ITF), all the partners are jointly and severally liable for the entire obligation and each part of it.

7. Sealing and marking of Offers

The original offer shall be typewritten or written in indelible ink and signed by a person or persons authorized to sign on behalf of the Tenderer using the Form of Tender provided in Annex III.

Tenderer shall seal the offer in an envelope or package. Please, clearly mark the envelope as follows:

“The procurement of material and consumables for the Palestine Hospital, Bethlehem (Harmalah).”

“Not to be opened before the Offers opening session.”

If the outer envelope is not sealed and marked as required, the Contracting Authority (ITF) will assume no responsibility for the misplacement or premature opening of the Offer.

8. Evaluation of proposals

The Contracting Authority (ITF) using the lowest price, minimum requirement criterion, will evaluate acceptable offers. All tenderers will be notified in written form selected by Contracting Authority (ITF).

9. Appeal procedure

Un-successful tenderer can complain to the decision of the Evaluation commission in writing in 7 calendar days after receipt of the notification on unsuccessful tender and until the deadline written in the notification. The Appeal has to be addressed to the chairperson of the Evaluation commission and has to be sent with registered mail or be delivered personally. The confirmation of payment in amount of 400 EUR or equivalent in local currency has to be enclosed to the Appeal. The payment has to be made on the ITF account - SI56 02922 0051268569, SWIFT BIC: LJBASI2X, NOVA LJUBLJANSKA BANKA D.D., Ljubljana, Trg republike 2, 1520 Ljubljana, Slovenia. In the case of justified Appeal, the amount will be returned to the tenderer. The chairperson, if the Appeal was sent in the prescribed deadline and if the confirmation of the payment is enclosed, sends the answer on the Appeal latest in 7 calendar days after the receipt of the Appeal. If not satisfied by the response to their Appeal, the Tenderer can submit a new Appeal within 7 calendar days upon receipt of the answer to the first Appeal, which is to be addressed to the ITF Director and has to be sent with registered mail or be delivered personally. In the answer of the chairperson of the Evaluation Commission the exact deadline for the submission of the appeals to the director has to be specified. The director is obliged to answer on the appeal in 10 calendar days after the receipt of the Appeal. The answer of the director is final and there are no other legal means to be undertaken. The Appeal submitted within a deadline and with required enclosure shall cause the temporary halt to of the realization of the Contract on which the Appeal is directed to.
