**INVITATION FOR SUBMISSION OF OFFERS FOR
ENHANCING OF STORAGE AND SAFETY CAPACITIES IN BALKYKHY,
KYRGYZ REPUBLIC IN 2021**

1. Publication reference:

2. Procedure:

Call for proposals for commercial construction companies.

3. Contracting Authority:

ITF Enhancing Human Security (ITF)

4. Description of the works:

- Renovation of five (5) warehouses at Balykhy military compound (warehouses 2, 3, 4, 5 and 7);
- Renovation/construction of one (1) warehouse in Balykhy military compound (warehouse 12);
- Installment of video surveillance and security alarms on all the warehouses.

All the detailed information will be given on request via the contact person listed below.

5. Eligibility and rules of origin

Participation is open on equal terms to commercial construction companies, international and national, which are registered to perform construction activities and possess license and all other relevant permissions to perform construction, issued by relevant national bodies of Kyrgyz Republic, and as per Donor's specific decision.

The company/organization submitting the offer shall have successfully completed as Prime or Sub-Contractor, at least 1 projects of the same nature/amount/complexity comparable to the procured works over the last 3 years, supported by the document(s)/confirmation(s) by relevant institution(s)/organization(s) (reference confirmation(s) – signed and stamped.

The company/organization is obliged to register and obtain DUNS number at <https://iupdate.dnb.com/iUpdate/confirmSource.htm> before applying for this Invitation for submission of offers.

The company's principals/officials must not be on the Specially Designated Nationals List (SDN) - <https://www.treasury.gov/resource-center/sanctions/sdn-list/pages/default.aspx> - of the U.S. Treasury Office of Foreign Assets Control (OFAC). The offeror itself is responsible to check the SDN list.

Donor's specific conditions and requirements shall be taken into consideration at all procedure.

6. Offer validity

Offer shall be valid for period of minimum 90 (ninety) days after the deadline for submission of Offer and must be accompanied by an Offer Guarantee (issued by offerors bank) in the amount of 500,00 USD. The guarantee shall be valid for a period up to and including minimum 90 (ninety) days after the deadline for submission of Offer. This guarantee will be released to unsuccessful Offeror(s) once the procedure has been completed and to the successful Offeror upon signature of the contract by all parties.

7. Performance guarantees

The successful company will be asked to provide a performance guarantee of 10 % of the amount of the contract at the signing of the contract. Performance guarantee shall be valid for a minimum of 180 days after signing of the contract. If the selected company fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the company, which has submitted the second best admissible offer.

8. Information meeting and/or site visit to inspect the project objects

Site visit to inspect the project objects with potential companies is possible and will be organized, according to schedule/plan ITF.
