5. Eligibility and rules of origin

Participation is open on equal terms as described to commercial companies and non-governmental organizations, international and national, which are registered to perform disposal and/or demilitarization of ammunition activities and possess license and all other relevant permissions to perform disposal and/or demilitarization of ammunition, issued by relevant national bodies, and as per Donor's specific decision.

The company/organization participating shall have successfully completed as Prime or Sub-Contractor, at least 1 project of the same nature/amount/complexity comparable to the herein included works over the last 3 years, supported by the document(s)/confirmation(s) by relevant institution(s)/organization(s) (reference confirmation(s) – signed and stamped).

The company/organization is obliged to register and obtain UEI – Unique Entity ID at <https://www.gsa.gov/about-us/organization/federal-acquisition-service/office-of-systems-management/integrated-award-environmentiae/iae-systems-information-kit/unique-entity-identifier-update> before applying for this Invitation for submission of offers.

The company's principals/officials must be searched through the System for Award Management – SAM.gov – which may be accessed through the following link <https://www.sam.gov/portal/public/SAM/>. The offeror itself is responsible to check the SAM.gov . Donor's specific conditions and requirements shall be taken into consideration at all the procedures.

6. Offer validity and offer guarantee

Offers shall be valid for period of minimum 90 (ninety) days after the deadline for submission of offer and must be accompanied by the offer guarantee (values of the offers guarantees are shown in the above table). The offer guarantee shall be valid for a period up to and including minimum 90 (ninety) days after the deadline for submission of offer. This guarantee will be released to

unsuccessful Offeror(s) once the administrative procedure has been completed and to the successful Offeror upon signature of the contract by all parties.

7. Performance guarantees

The successful Offeror will be asked to provide a performance guarantee of 10 % of the amount of the contract at the signing of the contract. Performance guarantee shall be valid for a minimum of 180 days after signing of the contract. If the selected Offeror fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the Offeror, which has submitted the second best admissible Offeror.

8. Information meeting and/or site visit to inspect the project list ammunitions items

Site visit to inspect the project ammunitions items with potential Offerors is mandatory and will be organized, according to schedule/plan of inspection as set within the Dossier documentation.

Please note that the Offerors' representatives must receive a permit from Ministry of Interior of Montenegro for storage entry and should submit a written request to ITF and Ministry of Interior of Montenegro at least seven (7) days prior to ammunitions inspection dates, as prescribed in the Dossier.

Offerors should contact ITF (gregor.sancanin@itf.si, ursa.marinsek-srot@itf.si, aldin.korjenic@itf.si) and Ministry of Interior, for submission of written request to Ministry of Interior of Montenegro (Mr. Milovan Joksimović, Head of the UXO Department, Rescue and Protection Directorate) at least seven (7) days prior to ERW inspection date, but no later than no later than **Friday, 25 August 2023 until 12:00 hrs**.

9. How to obtain the dossier

Interested eligible Offeror(s) may purchase the documents for the project at the ITF Headquarters in Slovenia (please contact Urša Marinšek Šrot at email address Ursa.Marinsek-Srot@itf.si), on **Tuesday, 29 August 2023 from 12:00 hours**, and in the following days. Offers must be submitted using the standard form included in the dossier, of which format and instructions must be strictly observed.

10. Deadline for submission of offers

The sealed Offers shall be delivered by registered mail or in person, to **ITF Enhancing Human Security, Trg republike 3, 1000 Ljubljana, Slovenia/EU** by, **Thursday, 21 September 2023 at 12:00 hrs** (local time). Any offer received after this deadline will not be considered.

11. Deadline for completion of works

All works on the projects under this Invitation must be completed at the latest by **30 April 2024**.
