## 5. Eligibility and Rules of Origin

Participation is open on equal terms for commercial companies and non-governmental organizations (*eligible entities*), international and national, which:

- (a) posses the Accreditation to perform the relevant technical methods and activities required to perform the humanitarian land release operations in Bosnia and Herzegovina issued by Ministry of Civil Affairs - Demining Commission of Bosnia and Herzegovina, and
- (b) which are effectively established (*eligible countries*) in the Member States, IPA III beneficiaries, countries in the European Economic Area and the Neighbourhood Area, and Countries for which reciprocal access to external assistance is established by Commission, and
- (c) the company/organization shall clearly and unambiguously (supported by official documents) present the extent of humanitarian Land Release, Mine Clearance, Technical Survey, Cluster Munitions Clearance or Battle Area Clearance they have performed as main contractor or have been involved in as a subcontractor over the period of past 3 years from the Invitation for Submission of Offers deadline.

## 6. Number of Offers per Contract

For each contract a separate offer shall be submitted. The Offeror may participate in only one offer for the same Contract.

The submission of more than one offer by the same Offeror on a single specific separate contract – as a prime contractor, will result in the rejection of all offers within the specific separate contract, in which the offeror is involved or participates in more than one role - as a prime-contractor.

The participation by an Offeror in more than one offer on a single specific separate contract - as a sub-contractor, will result in the rejection of all offers within the specific separate contract, in which the offeror is involved or participates in more than one role - as a sub-contractor.

The submission or participation by an Offeror in more than one offer on a single specific separate contract - as prime or sub-contractor, will result in the rejection of all offers within the specific separate contract, in which the offeror is involved or participates in more than one role - as a prime and sub-contractor.

## 7. Offer Validity and Offer Guarantee

Offers shall be valid for period of minimum 120 (one hundred and twenty) days after the Deadline for Submission of Offers, and must be accompanied by the Offer Guarantee - values of the Offer Guarantees are presented in the above table. The Offer Guarantee for each project shall be valid for a period of up to and including a minimum of 120 (one hundred and twenty) days after the Deadline for Submission of Offers. The Offer Guarantees shall be released to unsuccessful Offeror(s) once the offers selection procedure has been completed, and to the successful Offeror(s) upon signature of the Contract(s) by all parties.

## 8. Performance Guarantee

The successful Offeror shall provide the Performance Guarantee of 10 % (ten percent) of the contract amount at the signing of the Contract and prior to the start of contracted field activities. The Performance Guarantee shall be valid from the date of the signing of the Contract and until 60 days after the B HMAC Certificate(s) and Declaration(s) are issued. If the selected Offeror fails to provide the Performance Guarantee within the set timeframe, the Contract will be void and a new Contract may be signed with the second-best Offeror.

## 9. Information on the Site Visit Schedule

Visits to the B HMAC project task locations (sites), as listed in the table under Point 4, with interested potential Offerors will be performed according to the Site Visit Schedule, organized by B HMAC and ITF, in the period from 10 September 2024 to 27 September 2024.

## 10. How to Obtain the Dossier

Interested eligible Offeror(s) may purchase the complete Dossier documentation at the ITF Representative Office in Bosnia and Herzegovina from Wednesday, **02 October 2024**, 12:00 hours. Offers must be submitted using the standard offer forms included in the Dossier, of which format and instructions must be strictly observed.

## 11. Deadline for Submission of Offers

The sealed Offers shall be delivered by registered mail or in person, to **ITF Enhancing Human Security, Trg republike 3, 1000 Ljubljana, Slovenia / EU** by **Wednesday, 30 October 2024 by 12:00 hrs** (local time). **Any Offer received after this deadline will not be considered nor accepted.**

## 12. Deadline for Completion of Works

All works on the projects under this Invitation for Submission of Offers must be completed at the latest by **30 September 2025**.
