4. Description of the contracts:

Execution of Monitoring and Quality Control Works on following contracts:

1. Contract ITF-M&QA-01/15 in the area of Bosnia and Herzegovina for the period from 01.10.2015 until 31.12.2017.
2. Contract ITF-M&QA-02/15 in the area of Croatia for the period from 01.10.2015 until 31.12.2017.
3. Contract ITF-M&QA-03/15 in the area of Serbia for the period from 01.10.2015 until 31.12.2017.
4. Contract ITF-M&QA-04/15 in the area of Kosovo* for the period from 01.10.2015 until 31.12.2017.

**This designation is without prejudice to positions on status, and is in line with UNSCR 1244 and the ICJ opinion on the Kosovo declaration of independence.*

5. Eligibility and rules of origin

Tender Participation is open on equal terms as divided and described per contracts to commercial companies and non-governmental organizations, international and national, which possess the accreditation for monitoring and quality control of demining, technical survey and cluster munitions/battle area clearance projects, valid for the time of the planned start and finish of the works, issued by Mine Action Centre of country where works will be implemented, and are eligible to participate on Tender, reference No.: ITF-M&QA-01-04/15.

The company/organization is obliged to register and obtain DUNS number at <https://iupdate.dnb.com/iUpdate/mainlaunchpage.htm> before applying for this tender.

The company's principals/officials must not be on the Specially Designated Nationals List (SDN) - <http://www.treasury.gov/ofac/downloads/t11sdn.pdf> - of the U.S. Treasury Office of Foreign Assets Control (OFAC). The tenderer itself is responsible to check the SDN list.

6. Number of tenders

For each contract a separate Tender shall be submitted. Eligible Tenderers may participate on all four Contracts.

7. Tender validity

Tenders shall be valid for period of minimum 60 (sixty) days after the deadline for submission of Tender.

8. How to obtain the tender dossier

Interested eligible Tenderer(s) may purchase the Tender documents for the projects at the ITF office in Sarajevo (Bosnia and Herzegovina) from **26 October 2015** from 12:00 hours, and in following days. Tenders must be submitted using standard Tender form included in the Tender dossier, of which format and instructions must be strictly observed.

9. Deadline for submission of tenders
